- 1. How can the Commission contribute to the accelerated implementation of the 2030 Agenda? (up to 500 words)

- 2. In particular, how can the Commission contribute to the accelerated implementation of Sustainable Development Goal 16 (Peace, justice and strong institutions)? (up to 500 words) Contributions could address a range of issues, for example, proposals relating to:
- a. Enhancing the organization of the Commission's work: The Commission can review and improve its organizational structure and working methods to ensure greater efficiency and effectiveness in advancing SDG 16.
